



Self-determination skills are mandatory for successful transition planning. This workshop focuses on what people need to know to manage their own supports and what kind of information exists. Materials developed by three states (VA, NC, and CA) to enhance consumer participation in decision making about their lives will be presented. The Partnership for People with Disabilities at Virginia Commonwealth University, a University of Excellence (UCE) in developmental disabilities, collaborated with the Virginia Department of Medical Assistance Services to develop user-friendly materials that explain how to use consumer-directed services. These materials are the foundation for a

website designed to assist individuals and their supporters in directing their own supports and services. North Carolina took a unique approach through its Consumer-Directed Personal Assistance Services and Supports (CPASS) grant project, collaborating with all disability populations and service systems (mental health/developmental disabilities, aging, vocational rehabilitation, etc.) to develop materials relevant to all populations. The process used to develop the materials will be described, along with difficulties encountered, problems resolved, and how this approach strengthened the system. California's Consumer Advisory Committee also will share tools developed to enhance consumer participation in decision-making.
